REPORT OF THE COMMITTEE ON FINANCE, PLANNING AND ECONOMIC DEVELOPMENT ON THE STAMP DUTY (AMENDMENT) BILL, 2022

1.0 Introduction

The Stamp Duty (Amendment) Bill, 2022 was, at the 18th Sitting of the 3rd Meeting of the 1st Session of the 11th Parliament of Uganda held on Thursday 31st March, 2022, presented for First Reading and referred to the Committee on Finance, Planning and Economic Development for further scrutiny.

Rt. Hon. Speaker, the Committee considered the Bill through consultations with different stakeholders, hence this report.

2.0 Object of the Bill

The object of this Bill is to amend the Stamp Duty Act, 2014 to provide for the amendment of the stamp duty rate for agreements relating to deposit of title, deeds, pawn pledge of the total value; to provide for the amendment of the stamp duty rate for security bond or mortgage deed executed by way of security for the due execution of an office, or to account for money or other property received by virtue of security bond or mortgage deed executed by surety to secure a loan or credit facility of entry total value; to provide for the amendment of the stamp duty rate for trusts concerning any property made by any writing including a transfer from a holder of letters of administration or probate orders to a beneficiary and for related matters.

3.0 Methodology

The Committee held meetings and received memoranda from the following;:-

- i) Minister of Finance, Planning and Economic Development;
- ii) Uganda Revenue Authority;
- iii) Private Sector Foundation;
- iv) Uganda Manufacturers Association;

4.0 Observations and Recommendations of the Committee

According to a recent study titled: Costs of Tax Incentives to Uganda's Socio-Economic Landscape, tax incentives have not delivered on their expected purpose such as providing jobs, revenue to the government and attracting investment as anticipated.

The study by local and international civil societies indicated that on average,

government spends at least Shs75 billion every financial year on a range of companies that are entitled to tax holidays and exemptions on import and excise duties

The Committee observed that there is need for government to assess the criteria for tax exemptions and ensure a cost-benefit analysis of the same is undertaken before more exemptions are granted.

Recommendation;

The Committee recommends that Clause 2 amending Item 60 A (f) of the Stamp Duty (Amendment) Bill 2022 be deleted.
