THE SUPPLEMENTARY APPROPRIATION BILL, 2021.

MEMORANDUM.

The object of this bill is to provide for supplementary appropriation out of the Consolidated Fund under article 156(3) of the Constitution and section 25 of the Public Finance Management Act, 2015, of a sum of two trillion, one hundred forty-three billion, two hundred seven million, eight hundred twelve thousand, one hundred ninety five shillings only to meet additional expenditure for the Financial Year 2019/2020.

A BILL for an Act

ENTITLED

THE SUPPLEMENTARY APPROPRIATION ACT, 2021

An Act to make supplementary appropriation out of the Consolidated Fund under article 156 (3) of the Constitution and section 25 of the Public Finance Management Act, 2015, of a **sum of two trillion, one hundred forty-three billion, two hundred seven million, eight hundred twelve thousand, one hundred ninety five shillings only** to meet additional expenditure for the Financial Year 2019/2020.

BE IT ENACTED by Parliament as follows:

1. Supplementary appropriation

The supplementary appropriation out of the Consolidated Fund in respect of the first, second, third and fourth quarters of the Financial Year 2019/2020, for the purposes specified in column 1 of the Schedule to this Act, of the sums respectively specified in column 2 of the Schedule, is hereby allowed and confirmed.

2. Commencement.

This Act shall be deemed to have come into force on the 1st day of July, 2019.
